Dear Sirs and Madam,

We are writing you as co-defendants in the lawsuit recently filed by Planned Parenthood seeking to strip away important protections in Missouri law designed to keep women safe. Planned Parenthood is suing for the right to perform surgical abortions without having to comply with the rules for ambulatory surgical centers and without having a doctor who can admit patients at a local hospital in emergency circumstances.

The Saint Louis Planned Parenthood is one of the most dangerous abortion facilities in the country, even with the protections Planned Parenthood is seeking to set aside. From January 1, 2009, through April 6, 2016, there have been fifty-eight ambulance calls, or one every forty-six days. This is more than four Saint Louis area colonoscopy centers *combined*. Since April, there have been at least five more ambulance calls as Planned Parenthood continues to hurt women at such a horrendous pace.

Rather than address its practices leading to so many ambulance calls, Planned Parenthood now wants to loosen safety restrictions and export this devastation across the state. We are therefore writing in the expectation that you will all defend our laws and keep our communities safe.
