

Coalition for Life St. Louis Car Raffle 2019 OFFICIAL RULES

1. PROMOTION DATES: Tickets for the Raffle for Coalition for Life St. Louis (“Sponsor”) may be purchased from January 15, 2019 through November 17, 2019 (the “Raffle Period”). Tickets must be purchased by 11:59pm on November 17th, 2019 to qualify for the raffle drawing. Winners will be randomly selected through a drawing on November 22nd, 2019. The Raffle is subject to all federal, state and local laws and regulations.

2. RAFFLE PRIZE (S): Grand Prize – One randomly selected entrant will win either: 1) a new Chevy Equinox of his/her choosing (up to \$25,000 in value), or 2) a \$15,000 cash prize. 2nd Place – an entrant will be randomly selected to win \$1,000. 3rd Place – an entrant will be randomly selected to win \$500.

3. WHO MAY ENTER: The Raffle is open to all residents of the United States, who are eighteen years old or older. The following persons are not eligible to enter the Raffle: (i) employees or Board members of Sponsor, and (ii) the spouses or dependents of employees or of Board members of Sponsor.

4. TO ENTER: Tickets may be purchased online or in person from a Sponsor volunteer, employee, or Board member. Payments for online tickets may only be by credit or debit card. Any credit or debit card payment that is denied shall disqualify the pending purchase. All ticket sales shall be purchased online at the Raffle website (CoalitionForLifeSTL.com/Raffle). Any e-mail communications will be sent to the e-mail address provided by the entrant as part of the purchase. Such communication shall include purchase confirmation. Entrant is required to provide to the Sponsor a valid, functioning e-mail address, their telephone number, and correct payment information. For Raffle ticket sales in-person, entrants must give their e-mail address and telephone number along with payment of cash, check or credit card to the Sponsor’s volunteer or employee. Once a ticket has been purchased, it is non-refundable. Entry into this raffle may be obtained without a purchase or donation. A purchase or donation will not increase your odds of winning. Requests for mail-in entries must be received prior to the end of the Raffle Period on November 17th, 2019. Entrant may only request one ticket per mail-in entry.

5. DRAWING: Winners will be chosen at random and will be announced on November 22nd, 2019. Winners shall be required to provide the Sponsor with a signed affidavit confirming their eligibility under these Official Rules and applicable law, proof of age, and must agree to the following: 1) to release the Sponsor from any liability arising from the Raffle; and 2) to permit Sponsor to use the winner’s name, city, photographs and likeness in future press releases, public statements or advertisements without limitation or future compensation unless otherwise prohibited by law. Sponsor will provide a written liability and publicity release for the winners to sign in order to claim their prize. Upon verification of their eligibility and receipt of liability/publicity release, each of the winners will be notified of their selection. In the event one or more of the selected winners is or becomes ineligible or chooses not to participate, the Sponsor will randomly select an alternate from the remaining entries and upon verification of eligibility and receipt of release, the alternate shall be declared a winner.

6. PRIZES: By the end of the day of December 2nd, the Grand Prize winner shall be required to personally take delivery of the Grand Prize from Don Brown Chevrolet (2244 S Kingshighway Blvd; St. Louis, Missouri 63110), present acceptable personal identification and evidence of any legally required insurance, and pay off all applicable taxes and fees. Sponsor assumes no liability or responsibility in connection with the safety or performance of the Grand Prize awarded. Finalist Prizes will be in the form

of a check made payable to the selected winner and awarded after the winners are announced on November 22nd, 2019.

7. ELIGIBILITY and GENERAL TERMS: By participating in the Raffle, all entrants agree to abide and be bound by these Official Rules and the decisions of the judges, which will be final and binding with respect to all matters relating to this Raffle. If an entrant wins a prize and is found later to be in violation of these Official Rules, that entrant will be required to forfeit the prize. False, fraudulent or deceptive entries or acts will render an entrant ineligible and any entrant who attempts to defraud Sponsor in any manner in connection with this Raffle may be prosecuted to the fullest extent of the law. All entrants are subject to verification of eligibility and compliance with these rules. Odds of winning depend upon the number of eligible entries received. No transfer of prizes to a third party is permitted, and no substitution of prizes is offered, except that the Grand Prize of a new Chevy Equinox (up to \$25,000 in value) may be redeemed for a cash prize of \$15,000. Void where prohibited or restricted by law. Prize winners will be notified by telephone. Alternates will be selected and contacted if Prize winners cannot be contacted by telephone by the end of the day of November 20th. In addition to the affidavit of eligibility and liability/publicity release signed by all the winners, the Grand Prize winner will be required to pay the required withholding tax at the time of delivery of the Grand Prize and complete all required tax documents. Sponsor is not paying the withholding tax on behalf of the Grand Prize winner. In the event the tax form(s) are not completed and the withholding tax is not paid at the time of delivery, the Grand Prize will be forfeited and an alternate winner will be randomly selected from among the other entrants. All travel and transportation costs associated with collecting the prizes will be the sole responsibility of the winner. Sponsor is not responsible for: (i) any difficulties that an entrant may experience obtaining a Raffle ticket; (ii) any typographical or other error in the printing or advertising of the offer, administration or execution of the Raffle, or verification or announcement of prize/prize winner; (iii) or the payment of any taxes or fees associated with prize winnings. The maximum number of prize awards is limited to the prize list and quantity as stated in these Official Rules and Sponsor is not obligated to award more than the stated quantities. Sponsor, and its officers, directors, employees, agents, independent contractors, representatives, agencies and any other individuals or companies participating in the design, administration or fulfillment of this Raffle (collectively "Releasees") are not responsible for: any incorrect or inaccurate entry information; human error; technical malfunctions; theft, tampering, destruction, or unauthorized access to, or alteration of Raffle entries; typographical, printing or other errors; any problems with transactions, or any Raffle entries that are late, lost, incomplete, misdirected, stolen, mutilated, illegible, postage due or any combination thereof. All such entries will be disqualified, as will any entries submitted in a manner that is not specifically allowed under these Official Rules. Any Raffle entry that is obtained in a manner outside legitimate methods as stated in these Official Rules or distributed where prohibited by law will be considered void and will not be eligible for prize redemption. By participating in the Raffle, entrants affirm that they have read and accept these Official Rules. By entering this Raffle, entrants agree that the Releasees will not be liable for personal injuries, death, damages, expenses or costs or losses of any kind resulting from or in connection with participation or inability to participate in this Raffle or acceptance, possession or use or inability to use a prize or parts thereof including, without limitation, claims, suits, injuries, losses and damages related to personal injuries, death, damage to or destruction of property, rights of publicity or privacy, defamation or portrayal in a false light (whether intentional or unintentional), whether under a theory of contract,

tort (including negligence), warranty or other theory. By accepting prizes, winners release the Releasees from all liability and responsibility with respect to the acceptance, possession or use/misuse of prize or participation in prize-related activities (including any property loss, damage, personal injury or death). Releasees will not be liable to winner or any other person for failure to supply the prize or any part thereof, by reason of any acts of God, any action, regulation, order or request by any governmental or quasi-governmental entity (whether or not the action, regulations, order or request prove to be invalid), equipment failure, terrorist acts, war, fire, flood, earthquake, unusually severe weather, embargo, labor dispute or strike (whether legal or illegal), labor or material shortage, transportation interruption of any kind, or any other cause beyond Releasees' sole control. Sponsor may amend the Official Rules at any time.

8. CHOICE OF LAW: Each entrant agrees that (1) all claims arising out of this Raffle shall only be brought within the Circuit Court of Saint Louis County, Missouri, and shall be governed by the laws of the State of Missouri;
